

FLOOR AMENDMENTS - 2019 WASHINGTON STATE

Require a vaccinated vs. non-vaccinated study to be performed by researchers independent of the pharmaceutical industry.

Make a public health official or agency that disseminates false or misleading information regarding vaccine-targeted infections, vaccines targeting infections, or vaccination data guilty of a misdemeanor punishable only by a fine of no more than \$1,000.

Require, prior to the administration of any vaccine required for school or day care attendance, the provider administering the vaccine to notify the child's parent or guardian, or adult in loco parentis, of the option to consent to an antibody titer test to determine whether or not the individual has developed positive antibody titer.

Require recipients of live viral vaccines to be excluded from school for the duration of the possible shedding interval as indicated in manufacturer inserts.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless the United States Food and Drug Administration has conducted a pivotal trial that evaluated the vaccine to capture potential autoimmune, neurological, and chronic health effects that arise after administration of the vaccine.

Remove the prohibition against using the philosophical objection exemption for any vaccine.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless the vaccine has been evaluated for its potential to cause autism spectrum disorder.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless the Department of Health has publicly disclosed the injury rate of the vaccine when administered with other required vaccines.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless the vaccine is 100% free of mercury.

Require providers administering vaccines to record the health status of their patients prior to any vaccine administration and to report to the Vaccine Adverse Reporting System and record in provider records all adverse events that follow for three years, regardless of whether the administrator considers them vaccine-related.

Prohibit a vaccine product from being required if it is currently the subject of litigation concerning safety, efficacy, or fraud.

Require Vermont to assume financial responsibility for any injury or death resulting from the administration of any vaccine or combination of vaccines required by law.

Require Vermont to assume financial responsibility for all costs for the special medical and educational needs of those injured by any vaccine or combination of vaccines required by law.

Exempt private schools, private day care centers, and private preschools from any restrictions to vaccine exemptions.

Exempt charter schools from any restrictions to vaccine exemptions.

Exempt religious schools from any restrictions to vaccine exemptions.

Exempt homeschoolers and homeschool collaboratives from any restrictions to vaccine exemptions.

Exempt a child from vaccine requirements if a parent or guardian, or any adult in loco parentis, presents a written certification that the scientific knowledge base regarding vaccine products, vaccine targeted infections, or the human immune system of the signator are contrary to the required immunization measures.

Remove the prohibition against using the personal or philosophical objection to exempt a child from the measles, mumps, and rubella vaccine.

Prohibit a child who tests negative for current infection of any vaccine targeted infection during times of an outbreak from being excluded from school. Requires intermittent testing to be performed during the course of any outbreak, depending on the incubation time of the infection.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless the United States Food and Drug Administration (FDA) has evaluated the safety of the vaccine using a pivotal trial against a control group that received a placebo or another vaccine or substance licensed by the FDA that was evaluated against a control group that received a placebo.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless the vaccine has been evaluated for its potential to cause cancer.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless the vaccine has been evaluated for its potential to mutate genes.

Make the provisions of the bill prospective only. Grandfathers

holders of existing exemptions throughout high school.

Specify that a child with a family history of vaccine-injury qualifies for a medical exemption.

Require the consent of a parent or guardian prior to the vaccination of a child for whom a medical, religious, or philosophical/personal exemption is on file.

Prohibit the requirements for full vaccination from including the diphtheria, tetanus, and pertussis vaccine.

Prohibit requiring a vaccine as a condition for school or day care attendance, unless it is 100% free from mercury, formaldehyde, and human fetal tissue or DNA.
